DRIVING SAFETY COURSE (DSC) OR MOTORCYCLE OPERATOR TRAINING COURSE

Under the laws of the State of Texas, you may be able to require that **(one)** charge be dismissed by taking a driving safety course. However, you must provide written notice of your intent to the Court **on or before the appearance date** as shown on your citation.

NOTE: "A person who holds a commercial driver's license (CDL) is not eligible to take a driving safety course to dismiss a charge nor is the Court allowed, by law, to grant a deferred sentence." Also, if your charge is for a Construction/ Maintenance Zone Violation (with workers present) you are NOT eligible to take a driving safety course or receive a deferred sentence.

A CHARGE MAY BE DISMISSED BY COMPLETING A DRIVING SAFETY COURSE PROVIDED THE FOLLOWING REQUIREMENTS ARE MET:

1. You are charged with a moving traffic violation other than 25 miles or more above the posted speed limit;
2. You have not used this option during the preceding 12 months and you are not in the process of using this option for another offense;
3. You have a valid Texas Driver's License;
4. You provide the Court with proof of financial responsibility (insurance) that complies with state laws;
5. You provide a copy of your driving record and a certificate of course completion approved by the State of Texas.

IF REQUESTING DSC, READ AND SIGN BELOW AND RETURN TO THE COURT WITH YOUR PROOF OF FINANCIAL RESPONSIBILITY (INSURANCE) AND YOUR FEE ON OR BEFORE YOUR APPEARANCE DATE AS SHOWN ON YOUR CITATION.

I hereby request to take a Driving Safety Course (DSC) or Motorcycle Operator Training Course and enter a plea of no contest to the charge of: _____ and request the Court to dismiss the charge as provided by law. I certify that I have read and meet all the requirements as set forth above for DSC eligibility. I further understand that the DSC must be submitted to the Court within 90 days from the appearance date on my citation; otherwise the original fine amount must be paid.
